Implementing the Eagle Protection and Offset Program (EPOP) at NorthWestern Energy

A recent study found that the main anthropogenic causes of Golden Eagle mortality in the western US were shooting, collision, electrocution, poisoning, and trapping. This “take” of Golden Eagles can either be intentional (e.g., shooting) or incidental from otherwise lawful activities (e.g., collisions with wind turbines). Incidental take of Golden Eagles violates the Bald and Golden Eagle Protection Act. The US Fish and Wildlife Service can issue incidental take permits to industry to protect against prosecution as long as compensatory mitigation to offset eagle mortality is implemented.

Currently, the most common mitigation offsetting eagle incidental take is power pole retrofitting to

reduce electrocutions. The US Fish and Wildlife Service has approved a mitigation bank for eagle incidental take developed by Burns & McDonnell, an engineering firm headquartered in Kansas City. NorthWestern Energy has partnered with Burns & McDonnell to provide the power pole retrofits needed to fulfill mitigation for eagle incidental take. NorthWestern provided the first power pole credits in 2022. This presentation will review the development and implementation of EPOP.

Marco Restani directs the avian protection program at NorthWestern Energy. He has studied raptors in Montana for 40 years. Prior to his time at NorthWestern Energy, he was a wildlife ecology professor. Marco attended the University of Montana (BS), Montana State (MS), and Utah State (PhD).

Participants will look for eagles at designated stops from Billings Heights to Columbus, part of a national effort conducted annually by YVAS since 1997. Observers counted 46 Bald Eagles and 3 Golden Eagles along the route last year.

Trivia from 15 Summers of Banding

As the season of osprey nest monitoring wears on from spring into summer, the Project Coordinator sends humorous or motivational messages (make me proud...no slacking!) to the troops via the online 'Osprey Google Groups.' We received this one in July.

- Number of ospreys banded: 1091 (1090 nestlings and one adult rescued from twine)
- Number of nest visits: 475 (that's 950 up-and-downs in the bucket; I am a human yoyo)
- Number of mornings when banding took place: 176
- Number of squeezes of a pop-rivet gun to attach color bands: well over 3000
- Approximate cost of 1050 color bands: \$8000
- Counties where most nestlings were banded: Park (391) and Yellowstone (321)
- First nest banded: Holmgren (Nest 326)
- Average number of nestlings banded per nest: 2.3
- Time from 1st banded nestling to 1000th banded nestling: 13 years, 6 days, 23 hours, and 15 minutes
- Most nestlings banded in a day: 25
- Number of 4-nestling broods banded: 11
- Number of nestlings entangled: most (5 in 2020), fewest (0 in 2023 and 2026)
- Funniest item found in a nest: plastic roses (courtship offering? stolen from a cemetery?)
- Strangest things found in a nest: 2 nestlings and 3 eggs
- Grossest item found in a nest: underwear (yep, bottoms, ick)
- Number of companies providing in-kind use of bucket trucks: 7
- Number of times we got the truck stuck: 5
- Number of different linemen who helped me band: 71!
- What they drink: Bud Light, Coors Light, "dark stuff", Michelob Ultra, Miller Lite, PBR, Voodoo Ranger
- Tensest moment: an irate citizen reported me to law enforcement and then she showed up at the nest with a pistol

Fledging!

The 40 volunteer nest monitors for the Yellowstone River Osprey Project have watched nests vacate for the season and are turning in their data and observations. One of the season's highlights for observers comes when the young make their first flights. Fledging is usually accomplished 50-55 days after an osprey hatches. Observers might also discover that ospreys are individuals and don't always follow the script.

A page from the diary of an osprey observer...

August 18: Nest appeared empty when I arrived. After 30 minutes, I assumed the nestling had fledged and joyfully prepared to leave. I looked up one last time & saw a large nestling flapping around in the nest! Clearly, F's [female's] arrival was causing the excitement, but then I saw that she was sans fish. N [nestling] quit flapping and lay low in the nest.

F rose and hovered over N for 30 seconds, clearly saying, "Get off your butt, you lazy osprey!" I saw N flapping from the bottom of the nest with one feather pointed skyward - GASP! Was that miscreant giving his mother the WINGER?

F flew off, but immediately returned and hovered again over the N, to no avail. F then flew off, washing her wings of the whole situation.

N settled down. But then I started to worry. Maybe N WANTED to fly but COULDN'T! That's when I called Marco [Marco Restani, biologist] about a possible entanglement.

August 20: Marco called. He arrived to an empty nest and N standing in a tree.

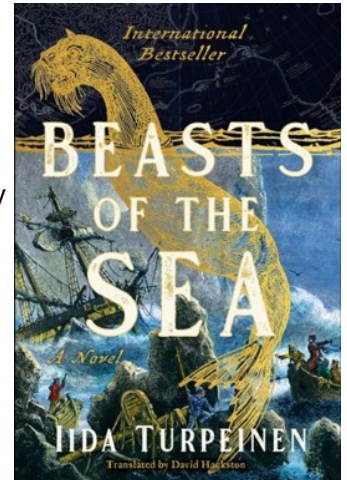

Russian Discoveries in North America

When my sister offered to loan her hardcover read midway through our sibling trip to Finland, I hesitated, reluctant to lug another weight in my backpack. But once I started **Beasts of the Sea**, a historical novel by Iida Turpeinen, I was hooked. The main story line of the book is the discovery and extinction of the Steller's Sea Cow, a giant plant-eating mammal related to manatees, that peacefully grazed kelp in Arctic waters until otter hunters found they were a tasty meal and killed them off in just 27 years. The only complete skeleton of this extinct animal resides in the Natural History Museum of Helsinki. The unwinding of the story concerns the extraordinary life of Steller, the naturalist, who, while shipwrecked in 1741 on Bering Island, managed to study the new species for science, and the other people in the following centuries who safeguarded the full skeleton that was found on the island in 1860. The concept of human-caused extinction is an underlying theme of the book.



The historical backdrop of this novel is Russian expansion and exploration under the Czars, when Russia grew eastward to the Pacific and staffed its navy with Scandinavian navigators and boat builders. Part of this time (1809 to 1917), Finland was under Russian rule.

Georg Wilhelm Steller, a German biologist and physician, was hired onto the sea voyage portion of the Second Kamchatka Expedition (1741-2) led by the Dane, Vitus Bering. The Czar Peter wanted to know where the furthestmost northeastern part of Siberia ended and where North America began.

So, what does this have to do with birds? Months into the voyage and plagued by fog and bad weather, Bering was about to abandon the effort to find North America and return home when land was sighted. A party of the crew disembarked to fill casks with fresh water on Kayak Island for just 10 hours and Steller accompanied them. In these 10 hours he collected and identified 144 plants and found an American blue jay that looked a bit like an illustration (The Blew Jay) in Mark Catesby's publication, "Natural History of Carolina, Florida, and the Bahama Islands," which he had seen in the St Petersburg Academy as a student. He shot the blue jay, so he had time to study it.

Because this new crested blue bird shared anatomical traits with the eastern American bird, Steller wrote in his journal: *"This bird proved to me that we were really in America."* Steller's Jay or *Cyanocitta stelleri*, entered the scientific literature as the name of this striking bird that is common in western Montana. Steller's Albatross, Steller's Eider, and Steller's Sculpin were other birds observed and described by him on this voyage that ended in shipwreck on one of the Commander Islands. Steller and some of the crew survived terrible hardship over 10 months of winter and Bering died, but in the spring, they built a boat to sail home. The extensive notes and observations made on the voyage and shipwreck island were sent to St. Petersburg and have been compiled and published. Steller stayed in Siberia until he died of a fever at the age of 37.
